1. AIMS AND OBJECTIVES: -

- 1. To establish and to run a Play Home, Baby Sitting, Nursery, Primary, High Schools, CBSE, ICSE Schools, College, (Kannada, English, Urdu Medium) Political Science Education, Technical institutions, Adult education, Commerce training college, M.C.A., B.C.A., Computer education in Software & Hardware, Networking, DTP, Auto Cadd and English Spoken Class, Tuition, Self employment, Evening College, Vocational training center, etc.
- 2. To open School of Nursing, College of Nursing, Pharmacy, Paramedical, Industrial training Society, Residential School, Law, Medicine, Medical, Sanskrit Medicine Institutions, D.Ed., CPD B.ED., Teachers training college, B.B.M., M.B.A., Dental college, Diploma training college, Engineering and other educational institutions.
- 3. To take over the Schools, College, Institutions and Building, to attend the objects of the Society. To conduct health awareness programmes camp, organize camps blood donations camps, etc.
- 4. To organize training camps in the field of industry, agriculture, sericulture, Horticulture, etc.
- 5. To give training in all types Musical instruments like Vocal, Tabala, Mrudunga, Mandolin, Guitar, Harmonium, painting and Flute and also Fine arts. To conduct Film acting, Drawings, Dance, Drama & Music competitions Taluk/District/National Levels. To propagation, supporting and development of Drama, Dance, Music, Drawings, and other fine arts.





RULES AND REGULATIONS

SIRI DHANU EDUCATIONAL SOCIETY

1. MEMBERSHIP: -

- a. The Society membership shall be as follows: -
- i. Life Membership Fees Rs.1,000/-,
- b. Any person and aged above 18 years will be allowed to become a member of Society. All members of the Society are eligible to vote and Contest to managing committee in the General Body Meeting.
- c. If the subscription of the member is in arrears for more than three months without satisfactory explanation to the Secretary, his/her name will be removed and the Executive Committee may reconsider his/her application for re-admission of membership.
- d. The termination of membership on death, the member acting against the objects of the Society unsound mind and other reasons stated by executive committee.
- e. All members may take part in the proceedings of the General meeting. Only such members who have completed minimum period of 6 months as members shall exercise their vote.

2. INFORMATION REQUIRED BY THE MEMBERS: -

Any member of the Society may apply to the Secretary for any information as may be required or any matter of the subjects or Rules and regulations of the Society.

3. GENERAL BODY AND OTHER MEETINGS: -

- a. A General body meeting of the Society will be held annually during the month of June.
- b. The report of the Management of the previous years working and the audited accounts for the one period and proceedings year shall be discussed and submitted for confirmation.
- c. An Executive committee consisting of 08 members shall be elected in the General body meeting once in three years.
- d. The Secretary may call for a General body meeting for which 21 days notice shall be given to the members.
- e. The Executive committee shall meeting once a month for which the Secretary shall give notice of 7 days to the members.
- f. Voting shall be conducted by show of hands or Secret Ballot.
- g. 21 days clear notice for the annual general body meeting and 21 days notice for the Special General body meeting shall be given, and the subject matters to be discussed shall be stated in the notice.

h. Special General body meeting shall convene as per Sec. 11 (3) of the K.S.R.Adt.

4. QUORUM: -

The quorum of the General body meeting shall be 2/3rd of the total membership of the Society.

5. ACCOUNTS: -

- a. The Official year of the Society shall be from 1st April to 31st March.
- b. The assets and liabilities the balance sheet of the Society shall be and laid before the Annual General body meeting for confirmation.
- c. Such a balance sheet and the list of Committee members shall be filed with the Registrar of Societies as per Sec.13 of the K.S.R.Act, 1960.

6. AUDITOR: -

An Auditor shall be appointed annually and the remuneration shall fixed by the members in the Annual General Body meeting.

7. EXECUTIVE COMMITTEE: -

- a. To ensure and promote the primary aims and objectives of the Society.
- b. To publish Annual report/accounts.
- c. To operate funds and manage the property of the Society and to present the duly audited accounts at Annual general body meeting.
- d. In the event of any office bearer laying down office for whatever reasons, the Managing committee can co-opt any member consider suitable for the office for the remaining period of the tenure or till election are held.
- e. To ensure utilization of income towards promoting the objectives of the Society.
- f. May decide to expel a member of Managing committee or member of the Society in case any one is convicted of any criminal offence, or prove insanity or any member's action in contravention to the Byelaws.
- g. To accept from Government, Non-Government, Local Bodies, Societies, NRI, Banks (Nationalized/Co-operative) and individuals Grants, Donations, Loans, Subscriptions or any property movable or immovable for furtherance of the objectives of the Society.
- h. At any meeting of the Executive committee each member present will have one vote except the President who shall have in addition a casting vote. Voting may be raising of hands or Secret Ballot.
- i. To ensure that all monetary transaction are through objectives of the Society.
- j. Managing committee shall have power to appeals and raise funds and fulfill and formalities incumbent upon it.
- k. Executive committee may appoint a committee, Sub-committee with such powers deemed fit by this body for the purpose of incommensurate with objectives. The committee, Sub-committee may co-opt persons who are members of the Society.

I. Executive committee may invite to their meetings for more than two specialists/experts who may be non-members of the Society whose presence with the deliberations is considered useful.

- m. To open bank account in the name of the Society in Scheduled/Nationalized/Cooperative bank and operate by President jointly with the Secretary of the Society
- n. Executive committee shall arrange for the publication in any manner Society journal, documents as may be considered fit in the furtherance of its objectives.
- o. To make the rules and Byelaws and get approved.
- p. To acquire or purchase, take on lease, hire or by gift or borrow loan from Schedules, Nationalized, Co-opt. Banks or other wise and hold any moveable or immovable property or properties or any right or privileges that may be deemed necessary or useful for the advancement of the objects of the Society.
- q. Hiring building for purpose of running schools and students hostels.
- r. Seeking government aid if necessary to run educational institutions.
- s. The Governing Body shall not admit members during the last three months of its tenure.

t. ELECTION:

Any member who is desirous of standing for the election as a member to the council of management shall be a member of the Society for at least 24 months prior to the date of nomination.

- 8. Any vacancy that may arise in the Executive committee may be filled in by the remaining committee members.
- **9**. Any member of the Executive committee being absent for three successive meetings without proper cause shall cease to be a member of the Executive committee.
- **10**. The Executive committee is to meet every month or earlier is any business to consider and Secretary shall convene such meetings 2/3rd shall quorum.
- 11. The executive committee in its meetings shall consider the entire question effecting business that may be of interest to the members of the Society and they shall inform and circulate any information, which may be of use to the members.

12. INVESTMENT: -

The funds of the Society shall be invested in the modes specified under the provisions of Sec.13 (1)(d) r.w.s.11 (5) of the I.T.Act, 1961 as amended from time to time.

13. AMENDMENT: -

No amendments to the memorandum of Society/ byelaws/rules and regulations shall be made which may prove to be repugnant to be provisions of sections 2(15), 11, 12 & 13 & 80G of the I.T.Act, 1961 as amended from time to time. FURTHER NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.

14. ACCOUNTS: -

There shall be maintenance of accounts of the Society. A Chartered Accountant shall duly audit the accounts. The Accounts shall be closed 31st March every year.

15. DISSOLUTION: -

In the event of dissolution or winding up of the Society the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Managing committee/Governing body but the same shall transferred to another charitable Society/Society whose objects are similar to those of this Society and which enjoys recognition u/s.80G of the I.T.Act, 1961 as amended from time to time.

16. CLAUSE: 6: -

The benefits of the Society shall be open to all irrespective of the caste creed or religion.

17. CLAUSE: 7: -

The funds and the income of the Society shall be solely utilized for the achievement of the objectives and no portion of it's shall be utilized for payments to the members by way of profit, interest and dividends.

18. CLAUSE: 8: -

The Association shall be irrevocable.

- **19**. Alteration or amendment of the Memorandum of Society shall be made as per Sec.9 of the K.S.R.Act, 1960.
- 20. Change of Name, Rules and regulations shall be made as per Sec.10 K.S.R.Act, 1960.
- 21. If the Dissolution of the Society arises Sec.22 and 23 of the K.S.R.Act, 1960 shall be followed.
- 22. Regarding the Amalgamation of the Society arises Sec.21 of the K.S.R.Act, 1960 shall be followed.
- 23. For the matters, which have not been specified, provided to therein above, the provisions of the K.S.R.Act, 1960 and the Rules made there under shall apply.
- 24. The Society funds and profits should be used for the purpose of reaching the goal and objects of the Society u/s.7 of Income Tax Act,1961. The Society working profit, interest, part of interest should not be distributed of or paid to the members of the Society.
- 25. To reach the Society goal and object achievement for all round development and activities to achieve the Society can receive foreign donations funds under F.C. (R) Act,1976.
- 26. To receive foreign donations separate bank account is to be opened. No other head of the accounts is to be transacted on said name of the account.
- 27. The working hours of the Society will be from: Morning: 09.00 A.M. To Evening: 06.00 P.M.

28. EXECUTIVE POWERS OF THE COMMITTEE.

The administration and Management of the Society shall vest in the Executive committee consisting of 07 members including President, Secretary, Treasurer and E.C. Members of the Society.

PRESIDENT: -

He/she shall be over all in charge of the Society and the General body meetings. All the policies and programmes shall be formulated and implemented only through him/her in consultation with executive committee.

SECRETARY: -

He/she shall call for all meetings of the General body meeting as and when deemed necessary and the General body meetings and the Special General body meetings as per the rules with the previous approval of the President and maintain the minute's book and record of all the proceedings of the meetings.

He/she shall be the correspondent of the Society and shall be in charge of the office with all the record of the Society.

He/she shall be the custodian of all articles and belongings both movable and immovable property of Society.

He/she shall file with Registrar of Societies, Bangalore relevant records of the Society for every year stipulated time without fail.

TREASURER: -

He/she shall be the custodian of all the funds and investments of the Society and all the accounts. He/she shall maintain all accounts and records and shall receive cash on behalf of the Society. He/she shall prepare a Balance sheet of the Income and Expenditure each year for the presentation to the General body with the approval of President and Secretary.

COMMITTEE MEMBERS will be participate in meeting and will join the office bearers while arriving at decisions in such meeting.




